Milan, 18 april 2019 – Please be advised that the Ordinary Shareholders' Meeting of Openjobmetis S.p.A. on 17 April 2019 resolved to distribute a dividend of Euro 0.23 for each eligible share. Furthermore, the Ordinary Shareholders' Meeting resolved that this Euro 0.23 dividend per share be payable, gross of tax withholding, from 8 May 2019 onwards, with ex-dividend date coupon no. 1 set for 6 May 2019 and record date (eligibility date for dividend payment, pursuant to article 83-terdecies of Legislative Decree No. 58 of 24 February 1998 and article 2.6.6, paragraph 2 of Stock-Market Regulations organised and operated by Borsa Italiana S.p.A.) on 7 May 2019.

In 2018 Openjobmetis SpA acquired 100% of Coverclip Srl, now Meritocracy Srl, the Italian digital platform for personal research, with the goal of embedding and developing Artificial Intelligence in the current job search and matching activities. In the same year acquired 70% of HC Human Connections Srl an educational company that carries out interventions dedicated to the development and coaching of Human Resources in organizations.
